

Backyard Hen Pilot Program



What's the (s)coop on the Backyard Hen Pilot Program?


Licensed and regulated keeping of Backyard Hens may be coming soon to Creston, but currently hens are not permitted in Creston. On July 19th, Council directed Staff to present bylaw amendments for a "Backyard Hen Pilot Program". On August 23rd, Staff presented the amendments to Council, and the Bylaws received 1st and 2nd readings. The proposed Pilot Program will allow up to 10 properties in Creston to keep a maximum of 6 hens for personal use for the 24 month duration of the Program. Roosters will not be permitted. Check out letstalk.creston.ca to view the Bylaws and proposed regulations.

On September 21st, Town Hall will host an informal public informational meeting to provide the public with an opportunity to chat with Staff and learn more about the Bylaws. September 27th is the anticipated date for the Public Hearing. If Council chooses, the Bylaws may be adopted on September 27th or October 11th.

Official Community Plan - Five Year Check-in

In 2017, the Town implemented a new Official Community Plan (OCP) with extensive community input. The OCP is **the most important planning document for our community**. It includes objectives and policies that guide planning and land use management, sustainability and resilience, long-term development plans, key projects, and much more. All bylaws enacted must be consistent with the OCP.



A lot has happened in the last 5 years, and now it's time to check in with you and revisit community goals and the vision for Creston.

Fall Yard & Garden Curbside Pick-up



The Town of Creston will be conducting the Fall Curbside Yard & Garden Curbside Pick-up in October.

The collection week will be October 11-14, 2022. Yard waste is collected by the Town Crew and is scheduled for your regular garbage day. Due to the overwhelming amounts set out, it is possible that the Crew will not collect it all in one day. Leave it out and they will continue where they left off the previous day. If it has not been collected 2 days after your garbage day, please call and let us know.

How to prepare:

- Branches and prunings (no larger than 6" in diameter) are to be wrapped in bundles of 3 feet (1 meter)
 a manageable size for 1 person to pick up.
- \cdot Leaves, twigs, grass cuttings, and organic garden

waste must be placed in rigid, weather proof containers (e.g., garbage cans, cardboard boxes), something that can be quickly dumped and returned to the curbside.

- · Paper garden bags are permitted.
- NO plastic garbage bags with yard waste will be accepted.
- We ask that you please keep all organic yard waste separate from household garbage when placing curbside for pick-up.
- Yard and garden waste may not be picked up if materials are not prepared as requested.

Please note:

- There is a second curbside collection week scheduled for the week of November 15-18; however, the date may change as it is weather dependant. Watch the Creston Valley Advance and our social media pages (Facebook and Instagram) for updates.
- A reminder that yard waste is for organics only and not 'anything found in the yard'. For example: broken lawnmowers, paving stones and garden gnomes are not accepted.
- The Creston landfill also takes yard waste for free in the months of April and October. Shrubs and tree branches must be less than 6" in diameter. Large loads (larger than 2.5m3 / one truck box) are at the discretion of the site attendant and may be turned away if the site is too full for the day or it looks like it is a commercial load. Plastic bags are NOT accepted at the organics station. Bags must be emptied and not left on location.

Here's a list of key engagement opportunities:

1. Respond to the mailout coming to you in

mid-September - For this mailout, we'll show what has been successfully completed in the last 5 years and what is still outstanding. We will seek feedback on what OCP projects you think are the most important, and check in to see if there are any new directions we should be considering.

2. Complete the weekly surveys on

letstalk.creston.ca this Fall - This survey series will review the current Community Goals and Policies and the Town's vision for Creston, which emerged from community engagement during the initial creation of the Official Community Plan. Tell us if you think it is still representative of your vision for Creston.

3. Subscribe to the letstalk.creston.ca project **page** - Find background information, get project updates and ask staff questions online.

4. Come to the open house in November - You are encouraged to attend to see and hear our plans. More details to come!

5. Reach out to Staff directly - It is important that as many residents as possible provide input during the 5 Year Community Check-in. The review will evaluate OCP policies within the context of today's challenges, trends and emerging issues and is an opportunity to touch base and ensure that the Town of Creston Official Community Plan continues to meet the community's needs.
